### How do I receive services from a provider in the network?

- Call the network provider of your choice and schedule an appointment.
- Identify yourself as a Davis Vision plan participant and Greater Pennsylvania Carpenters' Combined Funds, Inc. member or eligible dependent.
- Provide the office with the member's ID number and the name and date of birth of any covered dependent needing services.

It's that easy! The provider's office will verify your eligibility for services, and no claim forms are required.

### Who are the network providers?

They are licensed providers in both private practice and retail locations who are extensively reviewed and credentialed to ensure that stringent standards for quality service are maintained. Please access Davis Vision's website at [www.davisvision.com](http://www.davisvision.com) and utilize the "Find a Doctor" feature, or call 1-800-999-5431 to access the Interactive Voice Response (IVR) Unit, which will supply you with the names and addresses of the network providers nearest you.

### What about retail locations?

In order to provide our employees with the greatest amount of flexibility and convenience, Davis Vision makes available a number of retail establishments to our provider network. Benefits at retail locations may vary slightly from other locations, as noted in this benefit description. However, your value is comparable.

### What are the plan benefits, frequencies and costs?\*\*\*

**EYE EXAMINATIONS** ..... Every 12 months, including dilation as professionally indicated.  
**In-Network Copayment** ..... None.  
**Out-of-Network** ..... Reimbursed up to \$32.00

**EYEGLASSES** ..... Every 12 months  
**In-Network Copayment** ..... None.  
 You may choose from the Fashion selection of frames from "The Collection" in most network provider offices. A \$60.00 credit will be applied toward a network provider's own frame. Members who seek services through a participating retail location will be given a \$60.00 allowance toward the purchase of a frame. If you choose a frame with a price that exceeds the credit or allowance, you will be responsible for any balance. For more information on lenses, please see "What lenses/coatings are included?".  
**Out-of-Network** ..... Reimbursed up to \$30.00 for frames, up to \$25.00 for single vision lenses, up to \$36.00 for bifocals, up to \$46.00 for trifocals, up to \$72.00 for lenticular (post-cataract) lenses.

**CONTACT LENSES** ..... Every 12 months  
**In-Network** . Contact lenses may be selected in lieu of eyeglasses. Contact lens fitting and evaluation will be covered in full. One pair of standard daily wear contact lenses will be covered in full. A \$75.00 allowance will be applied towards all other contact lenses. Medically necessary contact lenses will be covered in full at all provider locations with prior approval.  
**Out-of-Network** ..... Reimbursed up to \$20.00 for daily-wear fitting and evaluation, up to \$30.00 for extended wear fitting and evaluation, up to \$48.00 for non-disposable contact lenses, up to \$75.00 for disposable contact lenses or up to \$225.00 for medically necessary contact lenses with prior approval.

Please note: Contact lenses can be worn by most people. Once the contact lens option is selected and the lenses are fitted, they may not be exchanged for eyeglasses. Routine eye examinations do not include professional services for contact lens evaluations. Any applicable fees are the responsibility of the patient.

## What lenses/coatings are included?

- Plastic or glass single vision, bifocal or trifocal lenses, in any prescription range.
- Post-cataract lenses.
- Oversize lenses.
- Polycarbonate lenses for dependent children, monocular patients and patients with prescriptions +/- 6.00 diopters or greater.

## Are there any optional frames, lens types or coatings available?

Yes, you can pay\*\* the low, discounted fixed fees indicated and receive these exciting optional items:

- \$20.00 for Designer frames from "The Collection".
- \$40.00 for Premier frames from "The Collection".
- \$15.00 for glass grey #3 prescription lenses.
- \$15.00 for fashion, sun or gradient tinted plastic lenses.
- \$20.00 for scratch-resistant coating.
- \$15.00 for ultraviolet coating.
- \$40.00 for standard ARC (anti-reflective coating). Premium ARC is \$55.00. Ultra ARC is \$69.00.
- \$65.00 for standard progressive addition lenses. Premium progressive addition lenses are \$105.00.+
- \$30.00 for intermediate vision lenses.
- \$20.00 for blended segment lenses.
- \$35.00 for polycarbonate lenses (for adults).
- \$60.00 for high-index (thinner and lighter) lenses.
- \$75.00 for polarized lenses.
- \$20.00 for Photogrey Extra® (photosensitive) glass lenses.
- \$70.00 for plastic photosensitive lenses.

*+ Progressive addition multifocals can be worn by most people. Conventional bifocals will be supplied at no additional cost for anyone who is unable to adapt to progressive addition lenses; however, the copayment, is not refundable.*

## When will I receive my eyewear?

Your eyewear will be delivered to your provider from the laboratory generally within two to five business days. More delivery time may be needed when out-of-stock frames, ARC (anti-reflective coating), specialized prescriptions or a participating provider's frame is selected.

## What about out-of-network provider benefits?

You may receive services from an out-of-network provider, although you can receive the greatest value and maximize your benefit dollars if you select a provider who participates in the network. If you choose an out-of-network provider, you must pay the provider directly for all charges and then submit a claim for reimbursement to:

## May I use the benefit at different times?

You may "split" your benefits by receiving your eye examination and eyeglasses (or contact lenses) on different dates or through different provider locations, if desired. However, complete eyeglasses must be obtained at one time, from one provider. Continuity of care will best be maintained when all available services are obtained at one time from either a network or an out-of-network provider. To maximize your benefit value we recommend that all services be obtained from a network provider.

## Information about Low Vision Services:

You and your covered dependents are entitled to a comprehensive low vision evaluation once every five years and low vision aids up to the plan maximum. Up to four follow-up care visits will be covered during the five year period.

## Information about Laser Vision Correction Services:

Davis Vision provides you and your eligible dependents with the opportunity to receive Laser Vision Correction Services at discounts of up to 25% off a participating providers normal charges, or 5% off any advertised special (please note that some providers have flat fees equivalent to these discounts). The following items are not covered by this vision program:

- Medical treatment of eye disease or injury.
- Vision therapy.
- Special lens designs or coatings, other than those previously described.
- Replacement of lost eyewear.
- Non-prescription (plano) lenses.
- Contact lenses and eyeglasses in the same benefit cycle.
- Services not performed by licensed personnel.
- Two pairs of eyeglasses in lieu of a bifocal.
